How much does a 10% tariff cost Spain?

The Spanish government's analysis indicates that under the current 10% tariff scenario, the direct economic impact amounts to approximately EUR1.388 billion, equivalent to 0.1% of Spain's GDP. This figure represents immediate costs to Spanish exporters and demonstrates the substantial financial implications of the new tariff regime.

What is Spain's tariff structure?

The overall tariff structure reflects Spain's position within the European Union's Common Customs Tariff framework, which maintains competitive rates for most trading relationships while adapting to new bilateral arrangements. For US products entering Spain, tariff rates average 3-5%, demonstrating Spain's traditionally open trade policy stance.

Spain's strategic position as a gateway to European markets has been substantially impacted by the new US tariff regime, which introduced baseline tariffs of 10% on most European Union goods, with specific provisions affecting Spanish exporters across multiple sectors.

What percentage of GDP is exported by Spain?

Spain, Exports of goods and services as percentage of GDP is 41.55 %. Tariffs imposed by Spain in 2022 are below. The maximum rate of tariff in percentage on any product is 175.99. The simple average tariff across all products is 2.06. The trade weighted average tariff is 1.39.
