What is the battery export Amendment?

The official Amendment follows a consultation draft published in January this year. The Amendment imposes export restrictions on key technologies relating to critical battery materials and minerals, impacting the upstream and midstream battery supply chain.

Can China halt exports if there are discrepancies?

Chinese customs authorities will have the power to delay or halt shipments if any discrepancies or uncertainties arise regarding the nature of the exported goods. This latest move builds on China's earlier export controls on natural graphite, lithium iron phosphate (LFP) cathode active material (CAM), and lithium processing technologies.

The Chinese government has introduced new export controls on key dual-use items, citing national security concerns. The move opened a new chapter in the ongoing trade confrontations with the US. Do you need a license to export lithium ion batteries?

Specifically, exports of lithium-ion battery cells or packs with a weight energy density of 300 Wh/kg or higher will now require a license. In addition, specialized manufacturing equipment such as winding machines, lamination machines, liquid injection machines, and capacity cabinets are also listed as controlled items.
