So even if you're not the first owner, your battery may still be under warranty. Your vehicle warranty may come in handy to replace your battery if it's still protected under warranty.

For example, if a battery has a 3-year free replacement and a 5-year pro-rated period, you'll get a full replacement within the first three years.
